Following investigations, I find that you are guilty of contravening the following Motorsport UK Regulation(s):

Q 12.21.4 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

Brief Details:

Car 117 pulled to the side of the track at post 23/24 (Becketts) the driver of car 117 self-extricated from the vehicle and had removed his helmet. At the point that the driver of car 117 stepped out of his car, car 195 lost control, spinning and hit the driver and car 117. Although not noted on the post chief report, car 195 stated that there was oil on the track which was the cause of losing control. Car 195 stated he did see the yellow flags prior to the incident and had slowed down as a result. The chief scrutineer reported that after inspecting car 177, there were clear signs of a loss of oil from the vehicle. A witness separate to the incident who was in the same race Car 2 corroborated that there was oil on the track at this location. Due to these mitigating circumstances, the penalty is much less severe than would normally be issued.

Accordingly, under Motorsport UK Regulation G 5.3, I hereby order that you receive the following:

Formal Reprimand
Number of Licence Penalty Points: 2

Additional Comments: Circuit CCTV was reviewed and driver of car 195 (Richard Evans) interviewed by Joe East (CoC) and Andrew Rowe (SCoC). Driver of car 2 spoke to Joe East (CoC) to inform of the oil on the track. Footage requested from car 195, but the onboard camera had not been configured correctly. Car 195 was asked to go to the Medical Centre for checks but declined. Car 117 and Car 195 both inspected by the Chief Scrutineer and reports collated
